## **LIABILITY RELEASE AND ASSUMPTION OF ALL RISK AGREEMENT**

Please read carefully and entirely, fill in the blanks, and sign where indicated.

I, \_\_\_\_\_, hereby affirm that I am completely and fully aware that all firearms training and operations have many inherent risks which may potentially result in physical harm, serious injury, or death. I acknowledge that the reaction to, possession of, handling, and/or use of firearms and live ammunition is potentially dangerous, and involves risk of serious personal injury, death, psychological trauma and/or other personal injury and financial liability. The undersigned agrees to assume any and all risk and completely and entirely waives any and all claims of liability for personal injury, death, psychological trauma and/or personal, financial, or material loss and the like.

I clearly understand and completely acknowledge that operating firearms with explosive components involves certain inherent risks which may require immediate medical treatment and/or transport to a medical facility; events such as but not limited to explosive detonations, misfiring, hang fire, and other malfunctioning of ammunition, the firearm or its components; ricocheting of projectiles, or impacted materials and other inherent events which may occur during the course training exercises. I understand that some of the activities which are essential and necessary for this training may be conducted at a site that is remote either by time and/or distance from a medical facility and I assume that risk and all that it entails and implies.

I understand that my instructor, Ron Anderson, the facility, institution, organization, corporation, business, club, building, and/or location at which I receive instruction, nor any of their respective employees, associates, officers, members, agents, contracts, assigns, attenders, participants or other parties (hereafter referred to as the "released parties") may be held in any way whatsoever liable or in any way responsible financially, materially, or otherwise for any injury, death, psychological trauma, loss, pain, suffering, material loss, or damage and the like that may happen to me, or my personal property and possessions as a result of my attendance, participation, and involvement in this firearms training or as a result of the negligence of any other party that participates in said same firearms training class or as a result of any latent defect in the facility, its equipment, furnishings, or environs, mechanical and physical, interior and exterior. Being fully aware, knowing, understanding, and comprehending the inherent risks and responsibility, I, of my own free will acknowledge, accept, and choose to proceed, attend, and participate with and in all the necessary activities involved in this firearm training course.

In consideration of being permitted to participate in this training course, I hereby knowingly assume all and any risks, whether foreseen or unforeseen, that may in any way whatsoever befall me while I am a participant in any way in this training course, including but not limited to

ingress and egress, academic exercises, travel, transition between locations if necessary, practical firing exercises and drills and/or all related activities, events, and exercises.

I further fully release, completely exempt, and hold entirely harmless said course instructor, assistants, and all previously mentioned released parties from any responsibility, liability, any and all claims material, financial, or otherwise or any lawsuit by me, my family (individually and/or corporately), estate, any and all heirs, representatives, administrators, executors, next of kin, or assigns arising out of and/or as a result of my enrollment, involvement, attendance, and participation in this training course before, during, and after the training course.

I also fully know and completely understand that shooting and participating in live fire exercises and firearms training is physically demanding and strenuous and that I will be exerting myself physically and emotionally during this firearms training course, and that if I am in any way whatsoever injured as a result of a heart attack, panic attack, hyperventilation, fainting, dizziness, seizure, or any other cause, event, or ailment, that I expressly and completely assume and bear all the risk and all the responsibility of said event and that I will not in any way whatsoever hold the instructor, assistants, or any of the other previously mentioned released parties responsible in any way.

I further state that I am of lawful age and legally competent to sign this liability release, or that I have acquired the written consent of my parent or legal guardian with their complete knowledge, understanding, acceptance, and agreement with all that is stated and implied in this document.

I fully understand and comprehend and acknowledge that the terms herein are contractual and legally binding, not a mere recital of conditions, and that I have signed this document of my own free will with the full knowledge and complete understanding that I hereby agree to waive all my legal rights without reservation or cause for recourse. I further agree that if any provision of this agreement is found to be unenforceable or invalid, that particular provision shall be severed from this agreement. The remainder of this agreement will be unaffected and be construed and stand as though the unenforceable provision had never been contained herein.

I completely understand and fully accept that I may, at the instructors discretion, be dismissed from and asked to remove myself from the training course classroom, range, and location including the premises at any time for any actions, behaviors, attitude, unsafe handling of a firearm, failure to follow instructions and/or any other behavior that the instructor deems unsafe, uncooperative, disruptive, or detrimental to the overall safety, purpose, attitude, and intent of the class. I willingly agree to immediately and fully comply with the instructor's

decision without argument or rebuttal. I also understand that should I be dismissed from the training course I forfeit any and all fees paid for this training course.

I understand that except in the case of extreme emergency I will not be refunded any fees paid should I not attend the training course. The instructor alone will decide if a credit or a refund will be given in case of extreme emergency.
